9. **Surrounding land uses and setting: Briefly describe the project's surroundings:**  
The subject property is located in an agricultural area and developed with improvements related to an existing dairy. Surrounding land uses include farmland planted in orchard with sparse single-family residences. The unincorporated community of Laton is approximately five miles southeast of the site.

**11. Have California Native American tribes traditionally and culturally affiliated with the project area requested consultation pursuant to Public Resources Code Section 21080.3.1? Under the provisions of Assembly Bill 52 (AB 52), participating California Native American Tribes were notified of the project and given the opportunity to enter into consultation with the County of Fresno on addressing potential cultural resources. Participating California Native American Tribes either did not desire to enter into consultation, or did not express concern with the project.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code Section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code Section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code Section 21082.3(c) contains provisions specific to confidentiality.

# INITIAL STUDY ENVIRONMENTAL CHECKLIST FORM (Director Review and Approval & Application No. 4688 & Initial Study No. 8185)
