Brief Description of the Project: Track I Agricultural Erosion Control Plan (New Vineyard + Legalize Existing) 1228 Hagen Abandonment of 0.35 acres of existing vineyard, legalization of 0.29 gross acres (0.20 net acres) of existing vineyard and conversion to vineyard of 0.96 gross acres (0.68 net vine acres) [resulting in a total of 0.88 new net vine acres on site] of gently sloped (2-15%) non-native black walnut orchard trees and annual grassland/existing vineyard (0.63 acres of 1.03 acres converted) located within the Spencer Creek Drainage on an approximately 6.1-acre parcel (APN 049-200-003; 1228 Hagen Road) located on the east side of Silverado Trail approximately 0.75 miles east of its intersection with Trancas Street/Monticello Road.
- 9. The project site is not located on the lists enumerated under Section 65962.5 of the Government Code, including, but not limited to lists of hazardous waste facilities.
