Project Description: Request for a Historic Alteration Permit to demolish the Samuel Carpenter Cottage, a County Designated Historic Landmark, located on a 20-acre agriculturally zoned parcel. The home, estimated to have been built around 1860, is in disrepair and is structurally unsafe, is located in a remote location that is not accessible by the public. The home would need to be raised in order to construct a new foundation and to install plumbing, along with significant restoration work on the deteriorated structure, making it economically infeasible to preserve the home. Demolition of the home would allow the applicant to retain the building site, preserve the unique setting surrounding the site, and provide for a new home in memory of the cottage.

Reasons why project is exempt:



The Class 1 exemption allows for the demolition and removal of individual small structures (i.e., one single-family residence) (15301(1)(1)). Issuance of a demolition permit (a ministerial action) will be required prior to the demolition and removal of the 746 square foot home.
