Allow an unmanned telecommunications facility consisting of a 105'foot-tall monopine wireless communication tower (monopine design) with related facilities on a 50' x 50' fenced site leased area of a 5-acre parcel in the RR (Rural Residential, two-acre minimum parcel size) Zone District.

The subject parcel is currently a wooded area composed of a single-family residence, with residential buildings located adjacent to proposed site. The surrounding land uses consist of rural residential, agricultural land and open space.
