Notice of Scoping Comment Period Extension

The California Department of Transportation (Caltrans) has extended the public scoping comment period for an additional 14 days until Friday, May 26, 2023 for the Vincent Thomas Bridge (VTB) Deck Replacement Project. The comment period began April 13, 2023 and two public meetings have been held. An in-person meeting was held April 27, 2023 at the East Wilmington Greenbelt Community Center and a virtual public meeting was held May 4, 2023.

The project proposes to replace the entire bridge deck, seismic sensors, the median concrete barriers, and the bridge railing of the Vincent Thomas Bridge. The proposed project alternatives contain different construction closure staging options that limit both operational impacts to the Port of Los Angeles and meet construction completion deadlines required in the funding of the project.

The purpose of this project is to preserve the structural integrity of the Vincent Thomas Bridge structure, restore safe driving conditions, and improve overall safety features. The bridge deck is rapidly deteriorating due to concrete fatigue caused by heavy truck traffic. The existing median and side barriers will need to be replaced, as they do not meet the requirement of the new Manual for Assessing Safety Hardware (MASH). If this condition is not addressed, it would affect the structural integrity of the bridge and the safety of the traveling public.

Preliminary environmental resource studies indicate that an Environmental Impact Report/Environmental Assessment (EIR/EA) is the appropriate environmental document. Caltrans will prepare an EIR/EA to evaluate the anticipated environmental effects and recommend measures to mitigate those effects pursuant to the California Environmental Quality Act (CEQA) and National Environmental Policy Act (NEPA). We welcome any comments or suggestions you may have concerning possible alternatives or potential social, economic, and environmental impacts as they pertain to the proposed project.
