## **Project Description:**

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis License submitted on 12/03/2020 and 1/14/2021, by Doug Chloupek. Doug Chloupek applied for a Distributor and Small Indoor license.

## **Project Activities:**

The Project will consist of a Use Permit Amendment to increase the maximum floor area for a previously approved medical cannabis cultivation facility (Permit No. P17-0322). The expansion consists of a new mezzanine within an existing building and increases the floor area from 29,888 to 36,588 square feet. The change is prompted by recently amended cannabis regulations for Stockton and enables the inclusion of additional on-site cannabis uses of non-storefront retailer (delivery) and distribution.
