Dear Mr. Ferrier:

Terry A. Hayes, Inc. retained Rincon Consultants, Inc. (Rincon) to conduct a cultural resources desktop assessment proposed the 429 Shoreline Village Drive Project, located in the City of Long Beach, County of Los Angeles, California. This memorandum documents the results of a cultural resources records search and Native American outreach. The proposed project is subject to the California Environmental Quality Act (CEQA) and local regulations. The City of Long Beach is the lead agency under CEQA.

# **Project Description**

The proposed project would include improvements, renovations, and expansion of existing buildings, demolition of three existing kiosk buildings, the construction of two small new retail buildings, and addition of a new two-level parking structure. The overall renovation will result in "no net change" in the commercial area of 82,368 SF per the project's original entitlement.

Additionally, site improvements shall also include a new bike path connection between the existing path along Rainbow Harbor and the Marina Green bike path. New short-term bike racks will be added and pedestrian circulation routes throughout the site will also be improved.

Newly remodeled public areas will include: the Hub Plaza, the boardwalk, view corridors between buildings, Harborside Plaza, and the public viewing deck. The size of the boardwalk will remain the same as no cantilevered areas will be added. Remodeled public areas will be enhanced with new paving, seating and other site furnishings. The parking lot will be repaved, restriped, and landscaped. New parking gates/pay stations will be installed as well as new stalls with EV chargers for electric vehicles. Excavations for the construction and refurbishment of the parking lot to include the new parking gates, pay stations, and EV charging stalls will not exceed depths greater than 2-feet below present grade.

The proposed project is located at 429 Shoreline Village Drive, City of Long Beach, Los Angeles County, California and lies within the *Long Beach* quadrangle, Township 5 South, Range 13 West, and Sections 01, 05, 06, 11, and 12 (Figure 1 and Figure 2, Attachment 1). The proposed project site is developed within the existing 429 Shoreline Village Drive site. The proposed project involves improvements, renovations, and expansion of existing buildings, demolition of three existing kiosk buildings, the construction of two small new retail buildings, and addition of a new two-level parking structure.



According to the City's General Plan Seismic Safety Element (1988) and historic aerial imagery (1953-1972), soils existing within the project site are from predominantly man-made fill and sand derived from ocean dredging, and hydraulic fill operations that created the site's landmass.

# Cultural Resources Records Search

On December 8, 2022, Rincon received the records search results from the California Historical Resources Information System at the South Central Coastal Information Center (SCCIC) at California State University, Fullerton for the proposed project. The purpose of the records search was to identify previously conducted cultural resources studies and previously recorded cultural resources located within the existing project site and within a 0.5-mile radius of the project site. In addition to the SCCIC records search, a review of the National Register of Historic Places, the California Register of Historical Resources (CRHR), the California Inventory of Historic Resources, the Built Environment Resource Directory, and the Archaeological Determinations of Eligibility list was conducted.

### Previously Conducted Studies

The SCCIC records search identified 16 previously conducted cultural resources studies performed within a 0.5-mile radius of the project site and two studies (LA-5403 and LA-12808) that were conducted within the current project site area (Table 1 and Attachment 2). The two studies that intersect the current project site are described in further detail below.

## Studies Intersecting the Current Project Site

### LA-05403

Community and Environmental Planning Division Department of Long Beach prepared study LA-05403, Environmental Impact Report (EIR): Queensway Bay Master Plan (SCH No.94081033). The EIR's Cultural Resources Section 6.14.1 and 6.15.1 consists of an overview that briefly describes the prehistory and history of the study area, the potential to encounter both marine and terrestrial sites/artifacts, evaluations, and findings. The Cultural Resources Section evaluated the potential to encounter coastal prehistoric sites, as unlikely or having a low potential, due to the high energy nature of the shoreline environment; prehistoric and historic sea crafts/vessels are unlikely or have a low potential, due to their



fragile nature and perishable materials, and there are no known historic vessels located within the study area. The Cultural Resources Section identifies seven structures as historically significant. None of these structures are located within the project site and will not be impacted or altered by the proposed project. There are no inundated prehistoric sites or isolated artifacts that have been reported within the study area. Consequently, no impacts are anticipated. The Cultural Section concluded that since there are no impacts anticipated, no mitigation measures are necessary (City of Long Beach 1994).

### LA-12808

Applied Earth Works, Inc. prepared study LA-12808, in support of the Analysis of Oil and Gas Well Stimulation Treatments in California: Environmental Impact Report (Wilmington Oil and Gas Field). The cultural assessment included portions of the cities of Carson, Los Angeles, and Long Beach that included the proposed project site area. The assessment relied heavily on data obtained from a literature review and a cultural resources records search conducted at the South Central Coastal Information Center (SCCIC), at the California State University, Fullerton. No fieldwork was conducted. Using the SCCIC record search results, in combination with extant geological, historical, and geographic information, a series of cultural sensitivity models were developed that identified the potential for archaeological and/or built environment resources within the Wilmington Oil Field area. The assessment found that large portions of the oil field had a moderate to high potential for cultural resources and provided mitigation measures to reduce potential impacts to less than significant by recommending location specific analysis for cultural resources prior to construction activities (Applied Earth Works, Inc. 2014).

### Previously Recorded Resources

The SCCIC records search results identified fourteen (14) cultural resources located within a 0.5-mile radius of the project site and one (1) historic structure was recorded within the project site. The one (1) historic structure is the "Shoreline Looff Carousel" (P-19-187089). Table 2 below summarizes the resources within a 0.5-mile radius of the current project site. A discussion of resource P-19-187098 (Shoreline Looff Carousel) is included below as it pertains to the discussion of the project site.

### P-19-187089

This historic resource has been identified as the Shoreline Looff Carousel that was first recorded by S. Ridgwelski in 1984, as part of the resource's petition to the State's Historical Resources Commission for designation as a California Historic Point of Interest. The Shoreline Village Carousel was constructed in 1906 by Charles Looff in Riverside, Rhode Island. The carousel's animals were hand carved antiques. Each animal was constructed with up to 200 pieces of wood, sectioned together like a jigsaw puzzle, and held together with wooden dowels, and hot animal glue, as no nails were used. The jeweled facade was cut glass from Belgium and the eyes were designed by a taxidermist. The tails were genuine horsehair. The carousel traveled at 14 mph, itsten ton weight was supported by a center-pole, and the machine capacity was over twenty tons. The carousel held 64 animals and four chariots. In addition to horses, there were also giraffes, rams, and camels (Ridgwelski 1984). In March of 1984, the State's Historical Resources Commission reviewed and approved the carousel's petition for listing in the California Register of Historical Resources (CRHR), listed number: P628. The Commission also approved the



carousel's designation as a California Point of Historic Interest: HRI No.LAN-035 (Ridgwelski 1984). In 1994, the Los Angeles Times, reported that the carousel was sold to the City of San Francisco, and therefore, there is no impact to this historic structure (LA Times 1994).

# Aerial Imagery and Historical Topographic Maps Review

Rincon completed a review of historical topographic maps and aerial imagery to ascertain the developmental history of the project site. Historical topographic maps of the 1896 *Long Beach* quadrangle to the 1972 *Long Beach* quadrangle depict the project site as part of Alamitos Bay (Ocean) (USGS 2020; NETR Online 2022).

The 1972 Long Beach quadrangle map depicts the project site as a sandy beach/shoreline(USGS 2020), which is confirmed by the 1972 aerial imagery that depicts the project site as a sandy beach/shoreline (NETR Online 2022). The 1975 *Long Beach* quadrangle map depicts the project site as "Marina Under Construction" (NETR Online 2022). Aerial imagery from 1978 shows retail buildings, restaurants, and a parking lot already in place (NETR Online 2020). By 1987, the current project site is depicted on aerial imagery (NETR Online 2022).

# Sacred Lands File Search

Rincon contacted the Native American Heritage Commission (NAHC) on November 22, 2022, to request a Sacred Lands File (SLF) search of the project site. As part of this request, Rincon asked the NAHC to provide a contact list of Native American groups and/or individuals culturally affiliated with the area who may have knowledge of tribal heritage resources at the project site and/or in the vicinity. The NAHC emailed a response on December 13, 2022, stating the SLF search was negative, indicating no tribal heritage resources are noted in the project site vicinity (see Attachment 2). Native American outreach was not part of this desktop assessment and was not conducted.

## AB 52 Consultations

Pursuant to Public Resources Code 21080.3.1. the City of Long Beach as the CEQA lead agency is conducting AB 52 consultations. As of this date, AB 52 consultations remain open and on-going.

# Site Inspection

A site inspection was not part of this desktop assessment and was not conducted.

### Findings and Recommendations

The background research did not identify any cultural resources within the project site, as the historic Shoreline Looff Carousel (P-19-187089) was removed from the project site in 1994. There are 13 historic buildings located within a 0.5-mile radius of the project site. None of these historic resources will be impacted or altered by the proposed project.

The project site was constructed circa 1975, from predominantly man-made fill and sand derived from ocean dredging, and hydraulic fill operations that created the site's landmass. The project site has been actively disturbed by commercial and recreational activities for at least the past 40 years. The existing



buildings and structures located within the project site have been determined to be less than 45 years old, and are not eligible for listing in the either the NRHP or in the CRHR.

It is unlikely that cultural (prehistoric and historic) resources exist within the project site, based on the reclaimed soils that underlie the project site and the current level of development within the site. Given the negative results of the background research, the negative results of previous studies within the project site, and the project site's underlying soil composition, Rincon recommends a finding of **no** *impacts to historical and archaeological resources* for the purposes of CEQA and does not recommend any additional cultural resources work at this time. Rincon recommends the following measures in the unlikely event of unanticipated discoveries of cultural resources, and existing regulations regarding the discovery of human remains.

### **Unanticipated Discovery of Cultural Resources**

In the event that archaeological resources are unexpectedly encountered during ground-disturbing activities, work within 50 feet of the find shall halt and an archaeologist meeting the Secretary of the Interior's Professional Qualifications Standards for archaeology (National Park Service 1983) shall be contacted immediately to evaluate the resource. If the resource is determined by the qualified archaeologist to be prehistoric, then a Native American representative shall also be contacted to participate in the evaluation of the resource. If the gualified archaeologist and/or Native American representative determines it to be appropriate, archaeological testing for CRHR eligibility shall be completed. If the resource proves to be eligible for the CRHR and significant impacts to the resource cannot be avoided via project redesign, a qualified archaeologist shall prepare a data recovery plan tailored to the physical nature and characteristics of the resource, per the requirements of CCR Guidelines Section 15126.4(b)(3)(C). The data recovery plan shall identify data recovery excavation methods, measurable objectives, and data thresholds to reduce any significant impacts to cultural resources related to the resource. Pursuant to the data recovery plan, the qualified archaeologist and Native American representative, as appropriate, shall recover and document the scientifically consequential information that justifies the resource's significance. The City shall review and approve the treatment plan and archaeological testing as appropriate, and the resulting documentation shall be submitted to the regional repository of the California Historical Resources Information System, per CCR Guidelines Section 15126.4(b)(3)(C).

### **Unanticipated Discovery of Human Remains**

In the unlikely event of an unanticipated discovery of human remains, all ground-disturbing activities in the vicinity of the discovery will be immediately suspended and redirected elsewhere. All steps required to comply with State of California Health and Safety Code Section 7050.5 and Public Resources Code Section 5097.98 will be implemented including contacting the Los Angeles County Department of Medical Examiner-Coroner. If the human remains are determined to be prehistoric, the coroner will notify the NAHC, which will determine and notify a most likely descendant (MLD). The MLD shall complete an inspection of the site and provide recommendations for treatment to the landowner within 48 hours of being granted access.



Figure 1 Project Regional and Location Map











Figure 2 Project Map
