The project proposes to allow maintenance and storage of trucks and trailers that transport only agricultural products, supplies and equipment on a 5.02-acre parcel located within the AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District.

9. Surrounding land uses and setting: Briefly describe the project's surroundings:

The subject parcel currently has a workshop, office, three storage sheds. Parcels to the north, and east contain one single family residence and several storage sheds. Parcel to the south and west are developed with agriculture.

Per Assembly Bill 52, participating California Native American Tribes were notified of the project proposal and given the opportunity to enter into consultation with the County on the project. No concerns were expressed by the Tribes. A Mitigation Measure has been implemented to address cultural resources should they be unearthed during ground-disturbing activities.

NOTE: Conducting consultation early in the CEQA process allows tribal governments, lead agencies, and project proponents to discuss the level of environmental review, identify and address potential adverse impacts to tribal cultural resources, and reduce the potential for delay and conflict in the environmental review process. (See Public Resources Code section 21080.3.2.) Information may also be available from the California Native American Heritage Commission's Sacred Lands File per Public Resources Code section 5097.96 and the California Historical Resources Information System administered by the California Office of Historic Preservation. Please also note that Public Resources Code section 21082.3(c) contains provisions specific to confidentiality.
