The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Testing Laboratory License submitted on 7/20/2020, by Carl Beardsley. Nature Safe Labs applied for a testing laboratory license out of an existing facility located at 885 GATEWAY CENTER WAY, SAN DIEGO, CA 92102 (APN 546-440-31). The applicant will store cannabis products for testing laboratory in 6,205 square feet of a 65,054 square foot facility.

Project Activities:

The Project will consist of 6,205 square feet of testing laboratory activities. The project will not expand the existing facility and minor tenant improvements are proposed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building facility with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
