Project Location: The Project is located at 18273 Bald Hill Road, Grass Valley, in Nevada County.

#### Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Cultivation License. This project will involve the indoor cultivation of 2432 square feet of mature cannabis canopy and 746 square feet of immature cannabis canopy.

#### Project Activities:

The applicant is seeking a Commercial Cannabis Permit for the cultivation of cannabis located at 18273 Bald Hill Road in Grass Valley, CA. The project is located on a rural, 8.24-acre parcel in an Agricultural zoning district. This project would include the construction of a 5,500 square foot commercial building that would contain both the 2,432 square feet of cannabis canopy and the 1,907 square feet of support area. The support area will consist of an immature plant area (746 square feet), drying area, secure storage area, processing area, restroom, office, pesticide and agricultural chemical storage area, and a mechanical room. Other functions of the commercial building include a shipping and receiving area, storage lockers, and a kitchenette.

The site is accessed by an existing road and is served by an existing well for water and an existing septic system for sewage disposal. No sensitive biological or cultural resources are known to occur on the project parcel. The site is surrounded by rural estates and open space with nearby cannabis businesses. The site is not within 600 feet of a K-12 school or a neighborhood park or community park. A notice of Applicability, and the Monitoring and Reporting Program were obtained by the applicant from the Central Valley Regional Water Control Board. An annual cultivation license from the California Department of Cannabis Control shall be obtained prior to the County Annual Cannabis Permit being issues.
