The Department of Cannabis Control, pursuant to authority granted under Business and Procession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Specialty Indoor and Nursery License submitted on 3/30/2022.

The Project will consist of Mature and immature cannabis cultivation. The project will reside within a 2,516 square foot facility that will accommodate 1,475 square feet for cultivation and 1,041 square feet for auxiliary services (hallways, restrooms, office, etc.).

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 and Class 3 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. Class 3 consists of construction and location of limited numbers of new, small facilities or structures; installation of small new equipment and facilities in small structures; and the conversion of existing small structures from one use to another where only minor modifications are made in the exterior of the structure. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
