DESCRIPTION OF ACTIVITY/PROJECT: The project consists of the development of a 120-unit affordable housing community comprised of five multi-family buildings, a community building and associated improvements on a 4.35-acre site within the Shopping Center (SC) zone and the Westborough PUD. The project includes a Density Bonus request with the provision of six (6) incomerestricted units for very-low-income residents (50% Area Median Income) pursuant to State Density Bonus Law (Gov. Code §65915-65918). The Density Bonus request includes a concession to development standards within the Westborough PUD that requires residential developments in the Shopping Center zone provide commercial uses on the ground floor. The concession to this standard allows the project to construct the development as proposed without the provision of ground floor commercial. The Density Bonus request does not include a request to exceed maximum density.
