The California Department of Transportation (Caltrans), as the lead agency under the California Environmental Quality Act (CEQA) and the National Environmental Policy Act (NEPA), is pleased to announce that the Draft Initial Study with Proposed Negative Declaration (IS/ND) for the State Route 1 (SR 1) Bridge Rail Replacement Project (Project) has been completed and will be released for public review and comment. This Draft IS/ND is also referred to as the Draft Environmental Document (DED). Additionally, a Draft Evaluation of Potential Section 4(f) Resources and *de minimis* Impact Determination has been completed for the Project and will be released for public review and comment.

The Project is located on SR 1 in Marin County, California, and proposes to replace and upgrade the bridge railing systems at the following four bridges:

- Coyote Creek Bridge/Location 1 (Bridge No. 27-0018) at Post Mile (PM) 0.42
- Eskoot Creek Bridge/Location 2 (Bridge No. 27-0077) at PM 12.37
- Olema Creek Bridge South/Location 3 (Bridge No. 27-0020) at PM 22.81
- Olema Creek Bridge North/Location 4 (Bridge No. 27-0021) at PM 22.96

Caltrans has analyzed the impacts that the proposed Project would have on the environment. The findings of the analysis are presented in the Draft IS/ND, which is available for review during a 30-day public review period from May 22, 2023, to June 20, 2023.
