Description of nature and purpose of the Project: The project proposes a Conditional Use Permit (CUP) for a new Cannabis Outlet (CO) in an existing 3,062 square-foot (sf) tenant space in a 6,208 sf building, on a 0.26-acre site. The project is in the IS-1-1 (Industrial- Small Scale) Zone of the Midway-Pacific Highway Community Plan, Coastal Height Limitation Overlay Zone, Parking Standards Transit Priority Area, Transit Priority Area, Transit Area Overlay Zone, Parking Impact Overlay Zone (Coastal Impact), North Bay Redevelopment Project, Airport Land Use Compatibility Overlay Zone, Airport Approach Overlay Zone, Airport Influence Area (San Diego International Airport (SDIA) and NAS North Island, Review Areas 1 and 2), 75+ Airport Noise Contours (CNEL), Airport Safety Zones, Airport Approach Overlay Zone, and the Federal Aviation Administration (FAA) Part 77 Notification Area (SDIA and NAS North Island).

Reasons why project is exempt: The City of San Diego conducted an environmental review and determined that the project would qualify to be categorically exempt from CEQA pursuant to Section 15301 (Existing Facilities). Section 15301 allows for the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing facilities (public or private), involving negligible or no expansion of use beyond that existing at the time of the determination. Since the project would only permit the partial conversion of an existing space for a CO which would not expand the use the exemption was deemed appropriate. The project is located on a developed site and no environmental impacts would occur and none of the exceptions described in CEQA Guidelines Section 15300.2 apply.


