The vegetation treatments include but are not limited to: fuels reduction, prescribed fire, reforestation, habitat restoration, thinning, and/or fuel reduction, and related activities including road reconstruction to facilitate completion of forest health treatments, as well as any and all related activities necessary to reduce the risk of high-severity wildfire on federal lands.
