The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Type 6 manufacturing License submitted on 01/20/2023 by Chris Hauder.

Project Activities:

The Project will consist of a cannabis non-volatile manufacturing business with cultivation activities located at 545 Searls Avenue, Unit 2, Nevada City, CA 95959. The APN is 005-280-019-000. It will operate out of an existing 17,210 SF building. The lot area is 99,752 SF. There will be approximately 4000 SF for cultivation and 500 SF for manufacturing. The business is currently not operational.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 32 Categorical Exemption Project. Class 32 categorical exemption for projects characterized as in-fill development. This exemption is intended to promote infill development within urbanized areas. The class consists of environmentally benign in-fill projects which are consistent with local general plan and zoning requirements. This class is not intended to be applied to projects which would result in any significant traffic, noise, air quality, or water quality effects. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
