NOTICE IS HEREBY GIVEN that the Oceano Community Services District (OCSD and Lead Agency) has prepared a Draft Initial Study and Mitigated Negative Declaration (IS-MND) for the project listed below pursuant to the California Environmental Quality Act (CEQA) State Guidelines §15000 et seq. Anyone desiring to comment on the IS-MND may do so in writing within the 30-day public review period, commencing May 1 through May 31, 2024. Project Title: Waterline Improvement Project

<u>Project Location</u>: The proposed project consists of multiple pipeline segments from OCSD's Capital Improvement Plan (CIP) located throughout the unincorporated community of Oceano in San Luis Obispo County, California. All but two pipeline segments associated with the project are located within the OCSD service boundary, with the remaining two pipeline segments located immediately adjacent to OCSD's northeastern boundary in the city of Arroyo Grande. Pipeline alignments would be located within the public right-of-way (ROW) within paved roads and dirt shoulders. The pipeline segments are shown in the map in **Figure** 1 and locations described in Table 1.

Brief Project Description: OCSD is a multi-service special district providing fire protection, sewer collection and water services, solid waste, parks and recreation, and street lighting to residents and businesses in the communities of Oceano and Halcyon in San Luis Obispo County, California. Several water mains in the existing OCSD system are approaching the end of their useful life expectancy. To address pipeline deficiencies, OCSD intends to install new pipeline main sections, replace existing pipeline main sections with upsized pipes, replace pipeline dead-ends with loops, and install an emergency intertie with the City of Arroyo Grande system. Project construction would occur over approximately one year and would utilize a combination of open-cut trenching and trenchless jack-and-bore construction techniques to install and replace pipeline segments. Project construction phases would include site preparation, pipeline installation (open-cut trenching or jack-and-bore), and paving/ground restoration. The project would result in approximately 76,150 square feet, or approximately 1.75 acres, of total ground disturbance, and would involve a typical maximum excavation depth of up to five feet. The emergency intertie between the OCSD system and the City of Arroyo Grande system would be located on Segment 2-10 along Halcyon Road. This intertie would be installed for emergency purposes only and would not alter the water supply capacity of either system. Existing operation and maintenance activities associated with OCSD's water system would be substantially reduced once all CIP segments are implemented. The pipeline segments are not included on existing lists of hazardous materials sites compiled pursuant to Government Code Section 65962.5.


